- Reducing exposure** to secondhand smoke, thirdhand smoke, and reduce tobacco product waste in the environment through smokefree outdoor dining patios, public places, and multi-unit housing policies.
- Reducing access to tobacco products** with comprehensive tobacco retail licensing (including, no sale of flavored/menthol products, minimum price and pack size requirements, reducing the number of tobacco retailers, restricting proximity to youth-sensitive areas, and eliminating sales in pharmacies, and prohibiting the redemption of coupons and multi-pack discounts.
- Promoting tobacco cessation**, treatment, and services, such as Kick It California (1-800-300-8086)
